MEMBER SPOTLIGHT: Amrit Mirpuri, L.A. Group of Companies CONQUERING NEW WORLDS FOR LA GROUP



The L.A. Group of Companies may be younger in age compared to other FICCI member companies, but it will not be a factor towards its future of growing.

Since the initial family-owned company, L.A. Car Accessories, was started in 2003 by Gary and his son Amrit Mirpuri, then just back from finishing his education in the United States, business has been growing and diversifying into what it is now, a five company group.

"Even when I was just 18 years old and studying in Florida, I already had ventured into my own business, Freshair Purification, together with a college professor of mine," said Amrit, now 41 years old.

The company supplied air and surface purifiers to homes, restaurants, and real estate companies, something he revived in the Philippines in 2020 as part of the group's growth.

However, it was the very first company, L.A. Car Accessories that set the tone for the future, " my father brought in the first of its kind , Tint Room Concept, an airconditioned, dust- controlled room for applying tint to cars.

And riding on the success of L.A. Car Accessories, it was a matter of time that Amrit started expanding and diversifying their technology driven group, L.A. Window Films Philippines, the sole supplier of safety films to major banks here, came next.

Tramigo, a GPS Vehicle Tracking System from Finland, was brought here, and already counts among others, big companies like Aboitiz, 2GO, Hertz, Alamo, and armored car companies. Presently it is Tramigo GPS Solutions with branches in Paranaque, Cebu, and Davao.

Then the revived Freshair Purification Solutions that addressed the Covid virus, and presently it serves local conglomerates SM, Ayala Malls, BPI, BDO, and Solaire.

Now comes the newest member of the group, Smart Hub Automation for homes and offices, and with way the group has been moving, nobody will be surprised to see it bringing more and more products and services using latest technologies.

"We were fortunate that even during this pandemic, we even managed to grow as our lines are aligned with the increased awareness by the general public on environmental safety," concluded Amrit, who just joined FICCI in 2017.
